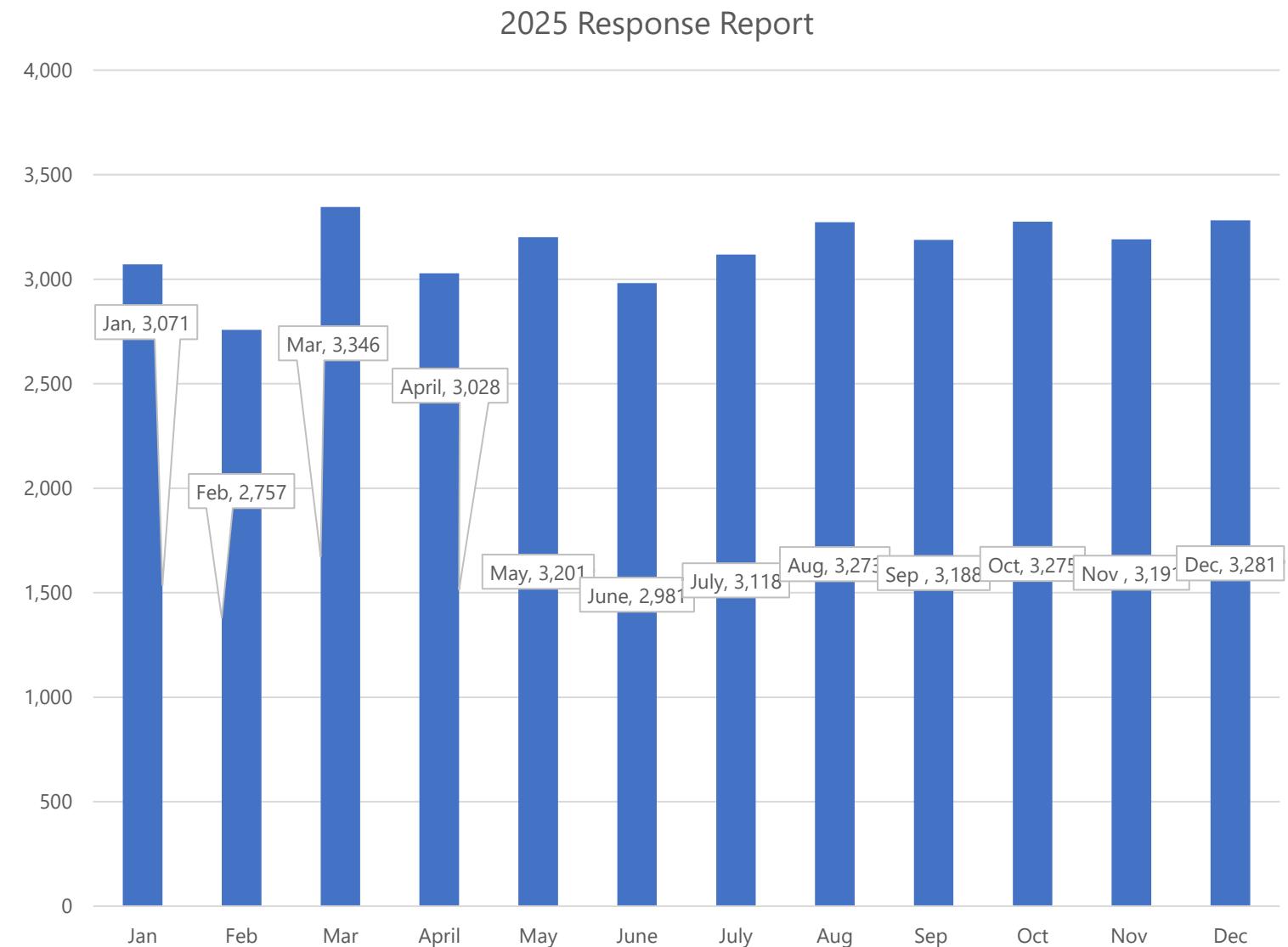

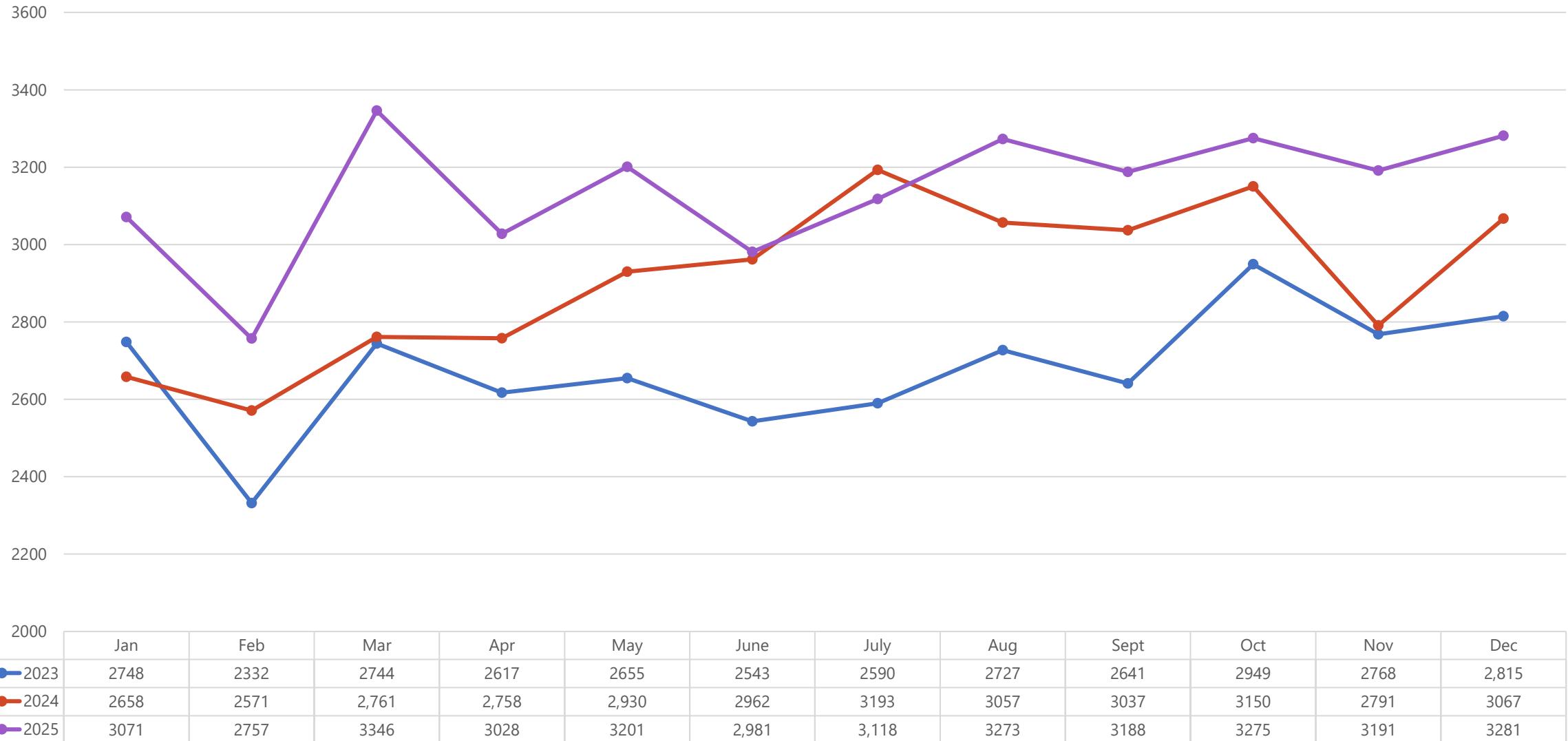

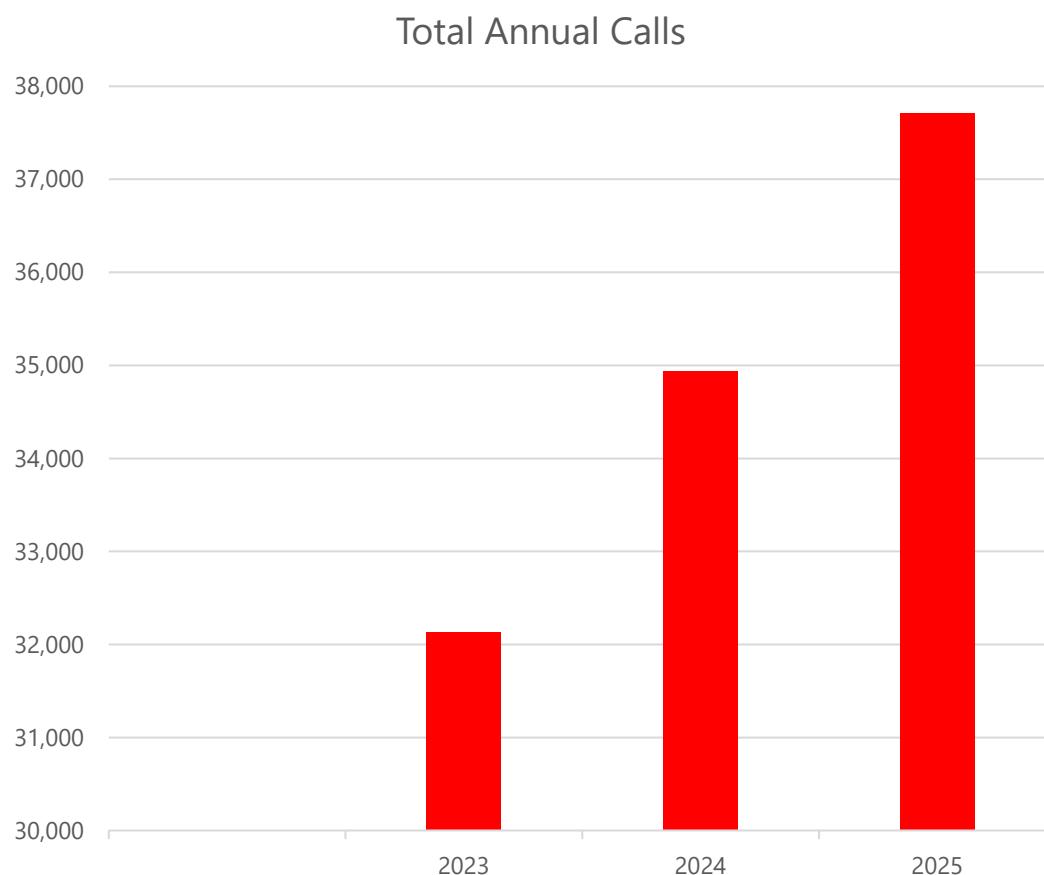


Total Responses for 2023, 2024 and 2025 Comparison

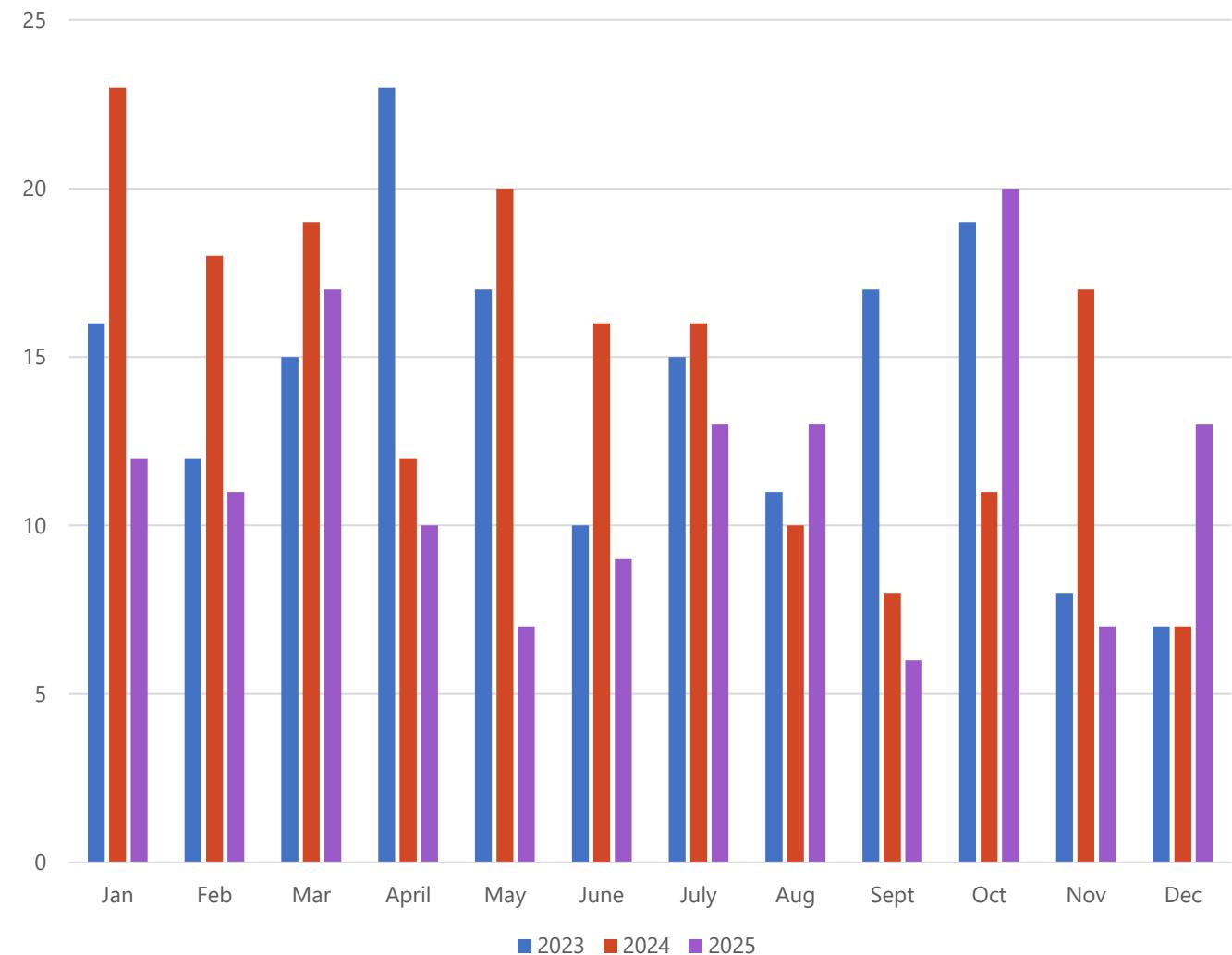


STEMI Report

STEMI is defined as a **ST** segment **Elevation** on our cardiac monitor.

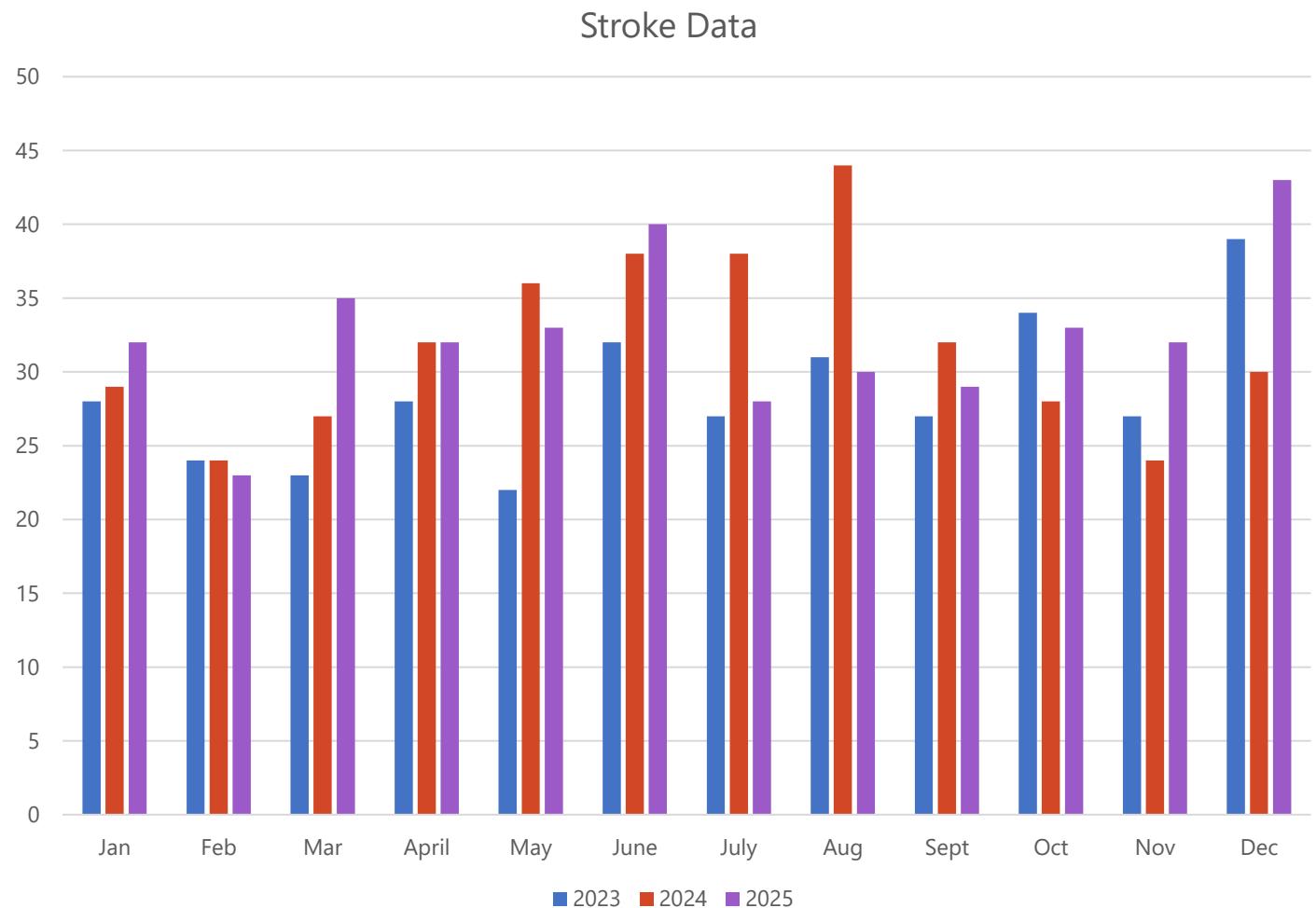
Also known as a **Myocardial Infarction**, or an active heart attack.

Stemi Data



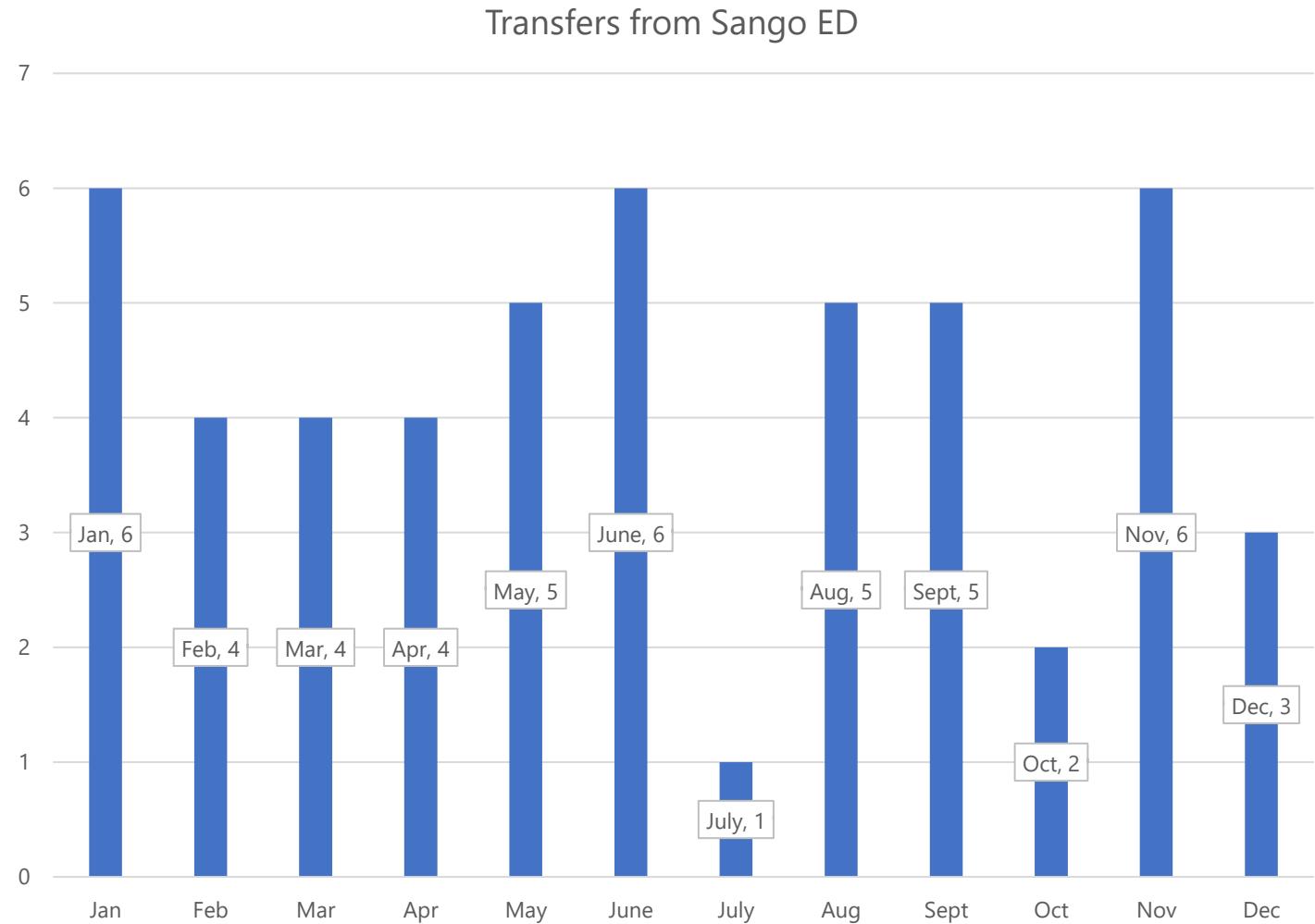
Clinical Reports Continued

- **Cerebral Vascular Accident**
- CVA is a Stroke: A Stroke is when a portion of the brain is not receiving blood flow.
- The majority of Strokes are caused by occlusions or blood clots in a similar mechanism as a heart attack.



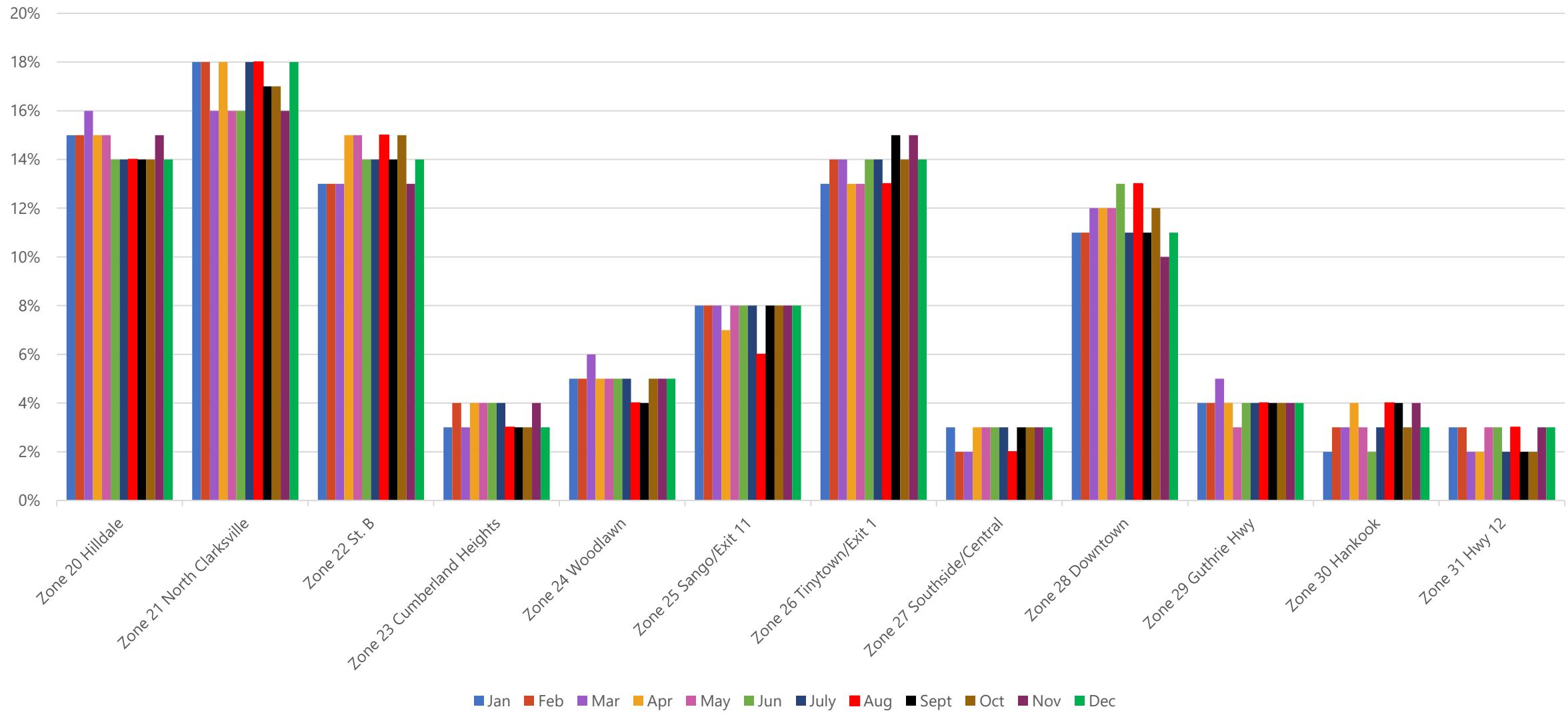
Transfers from Sango Emergency Department

- Transfers from Sango ED occur when no other resource is available, and the patient meets established clinical criteria for an immediate transfer to the main facility or a higher level of care at a Nashville facility.
- Examples:
 - Needing flight
 - STEMI
 - Emergent OB
 - Emergent Surgery

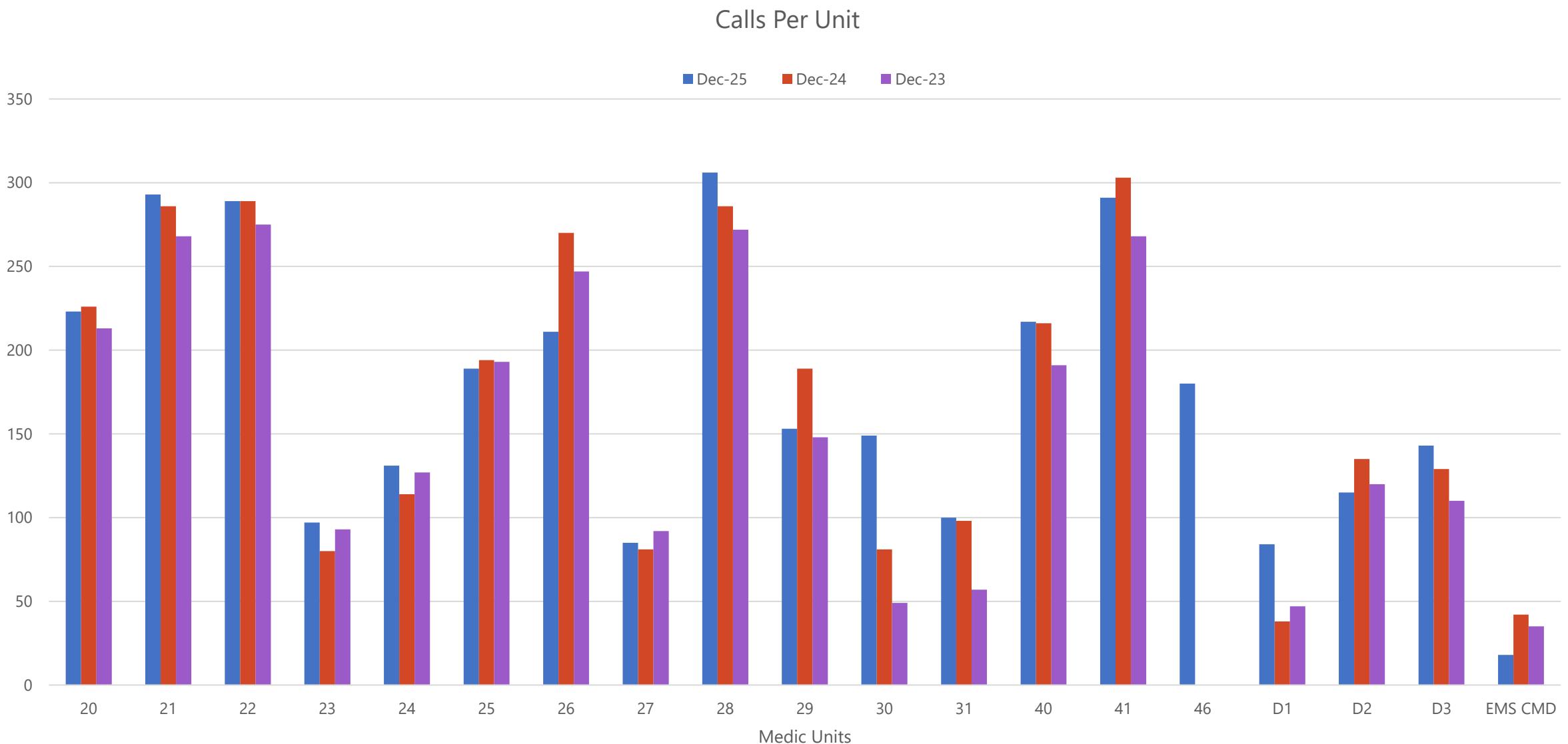


2025 Zone Responses
