CMCSS is proud to announce 11 schools in the district have been awarded the Tennessee Purple Star School Award. The Military Interstate Children's Compact Commission (MIC3). Tennessee selected just 18 schools across the state for this honor.

The Tennessee Purple Star School Award was designed to highlight military-friendly schools that show a major commitment to serving students and families connected to our nation's military.

Military-connected families make up 30-percent of the CMCSS population. Strong supports for military-connected students is a focus for the district, as well as providing resources and opportunities for students to learn about our nation's service members.

To earn the Purple Star designation, schools must have a point of contact within the school that has completed a professional development component specific to the needs of military-connected students. The school website must contain a page that provides resources for military families. The school then chooses an additional activity that aligns with the school's population and goals. To maintain the designation, the school must reapply every two years.
